**Treasurer Report (Dave Solmes):** A full review of the financial information was sent out early in the week and was reviewed during the meeting. \$8,100 was raised during the mattress sale event! **Concession Report (Megan and Jodie):** Full review of where the boosters stand on the transition of the head concession position from Deanna to Megan was discussed and moved forward. A review of a few low-cost items was discussed and approved for purchased such a box fan, some new garbage cans and a few other misc. items. There was a discussion about an earlier start time for concession to help ensure that all the equipment is up and running when the events begins. There needs to be further discussion on this topic. There will be a new inventory management process put together by Megan and Jodie to help minimize out of date product. A one game concession trial for the MI Patriots was reviewed and approved to see if there is any benefit available doing all 5 games while trying to balance volunteer's availability and the summer heat.
